**Subject: Request for amendment No. 1 to grant agreement No. 283286 - Project
title "HadronPhysics3"**

With reference to the above mentioned grant agreement, I request, on behalf of the consortium, to modify the grant agreement as follows:

1. Partial transfer of rights and obligations

Stichting VU-VUmc established in De Boelelaan 1105, 1081 HV, Amsterdam, The Netherlands, represented by Dr. Y. Kops, Managing Director Faculty of Sciences and/or Prof. Dr. H. Irth, Dean Faculty of Sciences, for the purposes of this grant agreement has taken over the rights and obligations of *Vereniging voor christelijk hoger onderwijs wetenschappelijk onderzoek en patiëntenzorg* as of "01/01/2012".

Any reference in the grant agreement to *Vereniging voor christelijk hoger onderwijs wetenschappelijk onderzoek en patiëntenzorg*, including Annex I and the table of the estimated breakdown of costs, shall be deemed to be a reference to *Stichting VU-VUmc*. Therefore *Stichting VU-VUmc* is a member of the consortium identified in Article 1.1.

Notwithstanding the transfer referred to above, the Commission and/or the European Court of Auditors and their authorised representatives shall continue to enjoy the rights referred to in Articles 22 and 23 of Annex II to the grant agreement in respect of work undertaken by *Vereniging voor christelijk hoger onderwijs wetenschappelijk onderzoek en patiëntenzorg*, which shall continue to be bound by the provisions of the grant agreement and its annexes relevant to the effective exercise of these rights.
